Type 3	Chemical Toilet Waste	\$ 0.2605	\$ 130.27	Chemical toilet waste and other high-strength wastes with a chemical oxygen demand greater than 10,000 mg/L.

<sup>(1)</sup> Septage Waste haulers are eligible for an 18.75% discount from the published Type 2 rate for any calendar month in which cumulative Type 2 volumes exceed 100,000 gallons. The volume discount is only available to accounts in good standing and will be rescinded for delinquencies or non-sufficient funds payments.

Septage Waste haulers must apply for and receive a septage hauler permit from the District prior to disposing of any Septage at the wastewater treatment plant. Waste must pass the appropriate screening tests before acceptance by the District for disposal.
